MINUTES

The main focus of this meeting was revising the IUPUI Faculty Annual Review (FAR) for the January 30th Policy Meeting. [See two revisions of the Faculty Annual Review Proposals as January 22 and January 23 files.]

- 1. Faculty Annual Review (FAR) Proposed Policy
 - Using the feedback provided by the IUB Faculty and Budgetary Affairs (FABA) Committee regarding the IUPUI FAR proposed policy, the IUPUI FABA Committee reviewed and discussed the feedback and revised its document accordingly. FABA members agreed to these additions or changes to the IUPUI Faculty Annual Review (FAR) proposed policy before sending to Policy Council for review and approval:
 - a. Committee Composition (Change): Two of the five members will be Non-Tenure Track Faculty (NTTF) at the doctoral level.
 - b. <u>Removal</u> of the Annual Performance Review Values and Guidelines for Tenure-line and Non-Tenure line faculty (Appendix A): Making arrangements for discussions of these aforementioned documents with all faculty.

- c. Merit Ratings: IUPUI will keep slight variation in language for Meritorious:

 IUPUI= Appreciably better than satisfactory but less than exemplary performance

 IUB= Noteworthy performance
 - d. Meeting of Non-Tenured, Tenure Track Faculty with Chairperson or Associate Dean for Academic Affairs and Research: <u>Affirming</u> that this meeting happens yearly
 - e. Receiving Meritorious or Higher Rating: Adding "research active" in the Rating section page 3

To receive a rating of Meritorious or higher, **research active** tenure and tenure-track faculty should provide evidence of at least one publication or substantial progress on a major project such as a book or longitudinal study.

2. Non Tenure Track Voting Update Currently, IUB and IUPUI FABA Committees will have separate proposed policies due to differences in positions regarding and actual composition of TT to NNT faculty. The Indiana University policy states that faculty composition should be 80% TT to 20% NTT.
