## Research, Development and External Partnerships Annual Report 2010-2011

This year the Research, Development and External Partnership committee continued its traditional role in reviewing and recommending funding for internal proposals. Prior to reviewing proposals, the committee revised each of the rubrics. Revisions were necessary as the committee felt that the previous rubrics did not adequately align with the proposal language provided to PIs. In addition to revising the rubrics, the committee agreed that it was important to provide feedback to proposals that were not selected for funding. The chair took notes on each proposal, solicited verbal/written feedback from all reviewers, and documented the discussion of each proposal. A summary of the strengths and weaknesses of the unfunded proposals were provided to the PIs. The goal was to provide constructive feedback to improve future internal and external proposals.

Committee members reviewed four Peace, three Proffitt Summer Faculty Fellowships, and nine Proffitt proposals. The committee recommended funding for all four Peace proposals, two Proffitt Summer Faculty Fellowships, and four Proffitt proposals. Associate Dean Sherwood generally agreed with our recommendations and in addition offered two additional awards to proposals. This occurred as a result of a discrepancy in the figures provided to the committee. We were given parameters for funding that were less than the amount of funds available. In the future it is recommended that the committee a) receives no information about the available funding or b) given the exact amount of fund available. Both options provide the committee with information that can help facilitate a fair and efficient review process. See Appendix A for titles of funded proposals in all three categories.

In addition to reviewing internal proposals the committee has decided to act upon its stated charge to advise the Associate Dean for Research on matters pertaining to research. Committee members expressed concern with the efficacy of support structures currently in place. Specifically, the committee believed that the support structures were inconsistently based on campus location, academic rank, type of research conducted and affiliation with centers. Therefore we are pursuing a review of the support structures during the upcoming academic year. We will begin with a review of the revised Promotion and Tenure Guidelines, the three-year review of Associate Dean Sherwood, and the stated policy that PIs run grants through the six IU School of Education research centers. Based on those findings, we may engage in interviews with faculty and administrators at both campuses. It is anticipated that we will report on our findings and submit a set of recommendations to the Associate Dean for Research by January 1, 2012.
